# AI & Machine Learning

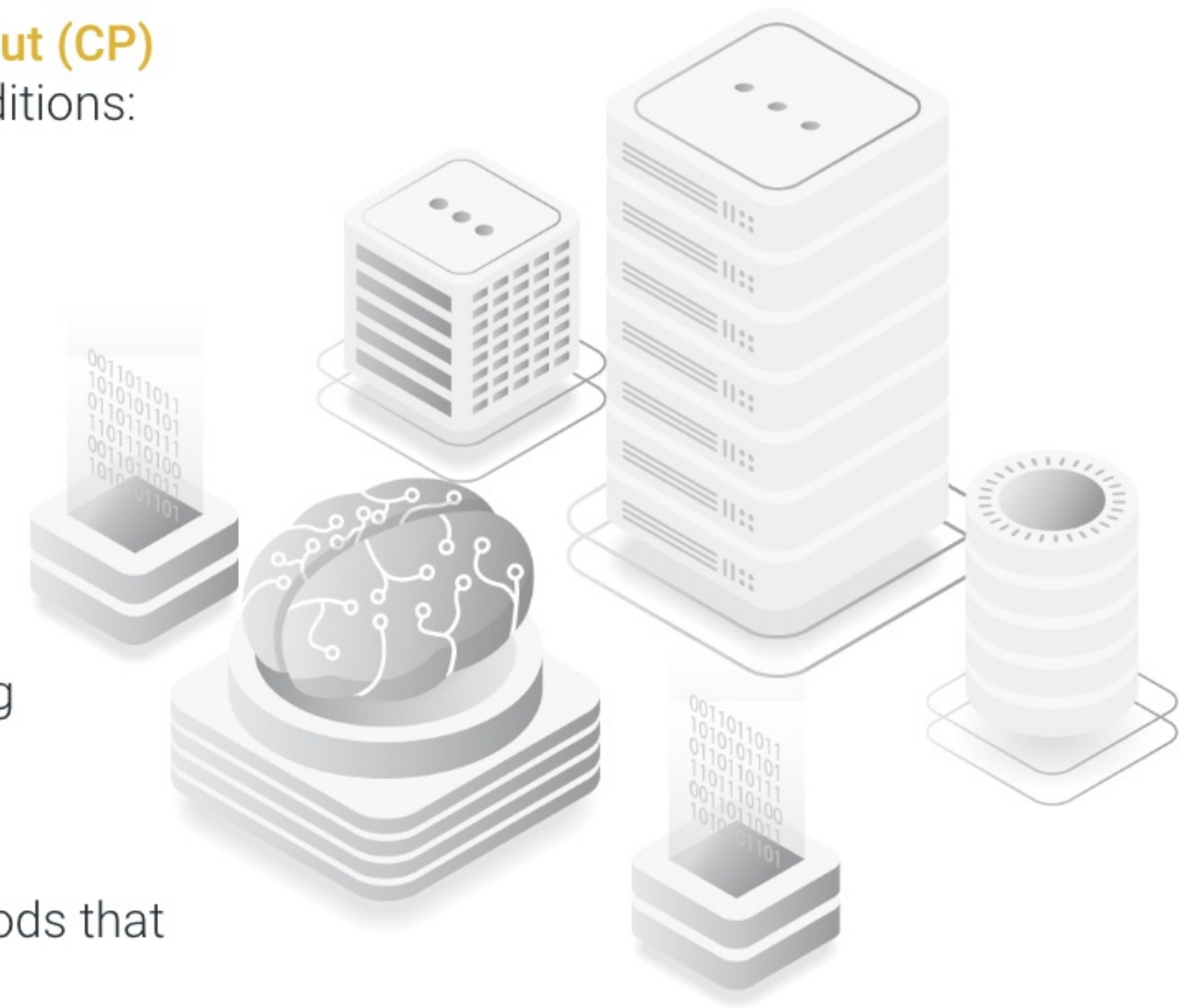
The Active Treasury Strategy combines the **Covered Call (CC)** and **Covered Put (CP)** strategies, with a flexible allocation split of 70% to 30% based on market conditions:

Market Conditions	70% Allocation	30% Allocation
Bullish Market	CP	CC
Bearish Market	CC	CP

A proprietary **AI programme** :

 Monitors and assess market direction by screening indicators and conducting fundamental analyses of the blockchain.

 Runs **ML algorithm** for trade signaling utilising world class quantitative methods that **back-test the success rate (over 90%)** of any identified trade signal.

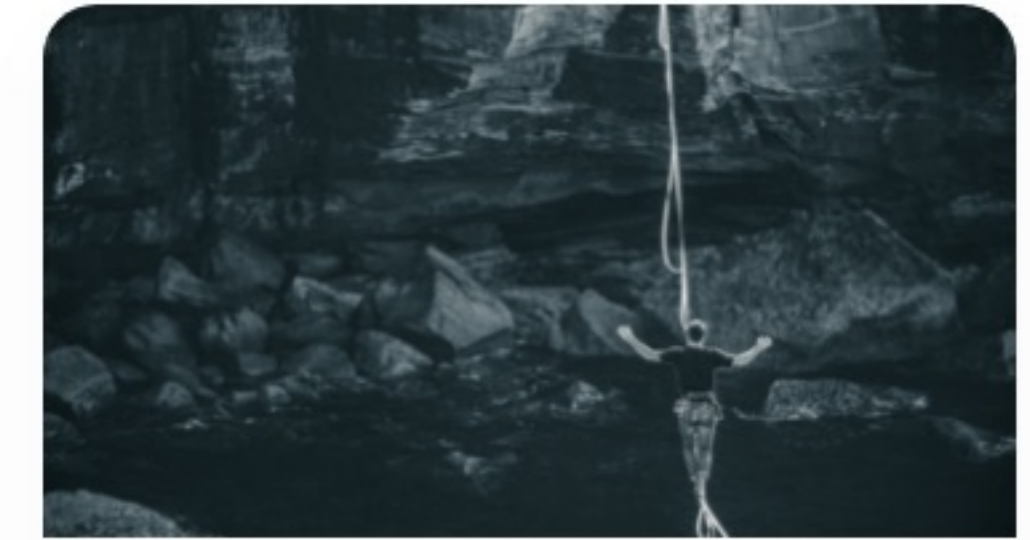

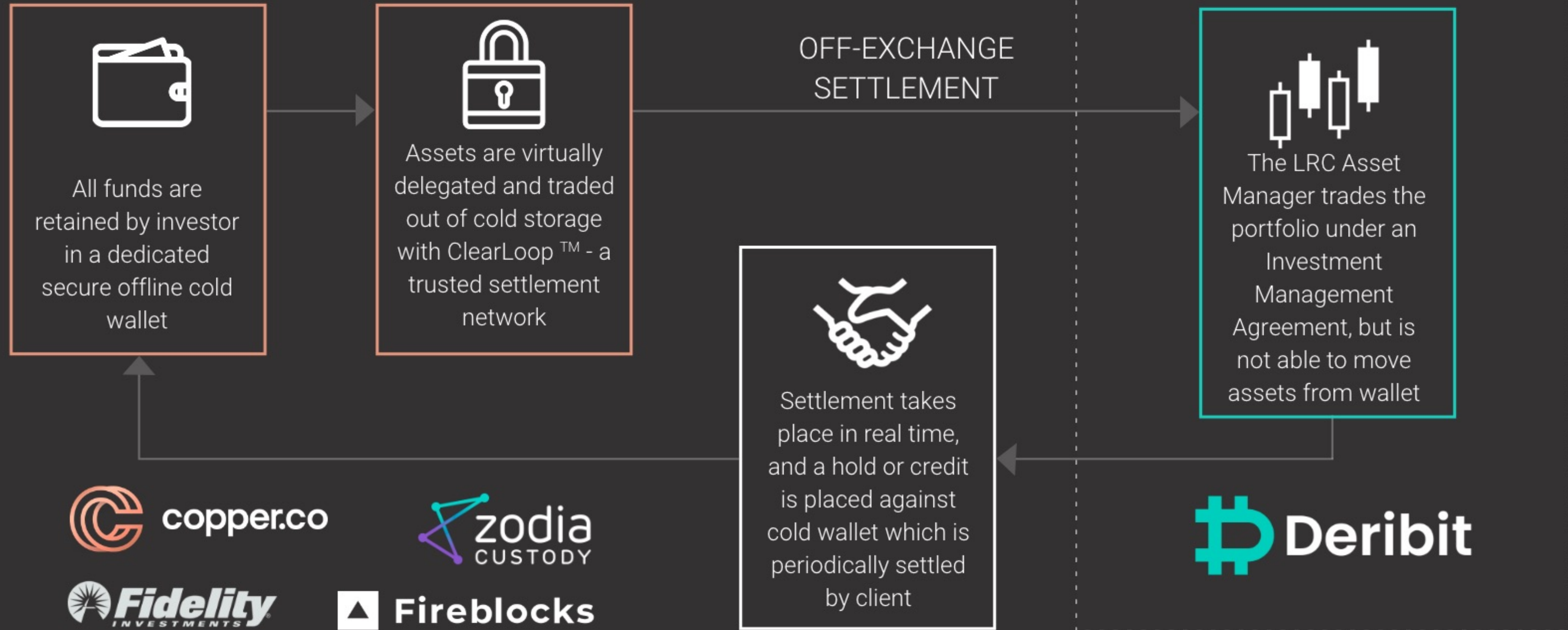

# Risk Management

## Investment Management Process

### Liquidity Risk

- ✦ Real-time monitoring of liquidity
- ✦ Strategic long bias positions

### Counterparty Risk

- ✦ Cold storage
- ✦ Sophisticated MPC wallet
- ✦ 2 of 3 signature control
- ✦ 2 keys retained by coin owner

### Event Risk

- ✦ Tactical hedging of tail risk events
- ✦ Strict risk limits & internal protocols

### Technical Default Risk

- ✦ Ongoing engineering analysis of digital assets
- ✦ Real-time onchain data feeds and analytics

## Best practices

- ✦ No single person, server, vault location or device failure can compromise our operations
- ✦ MPC wallet authorization for fund access
- ✦ Exchange partners rigorously selected based on data security practices & management
- ✦ Short term positions managed with strictly imposed risk limits
- ✦ Mitigating exposure via e-wallets, exchange accounts & other counterparty risks
- ✦ Overseen by independent risk management committee
